XUPERMASK PRIVACY POLICY

INTRODUCTION

XUPERMASK OPCO LLC ("XUPERMASK", "we", "our", "us") and its subsidiary and affiliate companies respect the privacy rights of its online visitors ("you", "your", "yours") and recognize the importance of protecting the information collected about them. This Privacy Policy addresses the use and disclosure of personal information we collect from you.

By visiting this Site, or providing your information to us, you are accepting the practices described in this Privacy Policy.

Please exit this Site immediately if you do not accept this Privacy Policy or are accessing this Site in a country or other territory where use of this Site is not permitted.

USE AND COLLECTION OF INFORMATION

We do not share with others, or sell or rent to others, any personal information that you provide to us through this Site except with your consent or as described in this Privacy Policy. We may engage third parties to perform services in connection with the operation of our business. Examples of these services include payment processing and authorization, fraud protection and credit risk reduction, product customization, order fulfillment and shipping, marketing and promotional material distribution, Site evaluation, data analysis and, where applicable, data cleansing. We provide personal information to these third parties, but we authorize them to use this information only in connection with the services they perform. We will also share information with our business partners. For example, we will share information with business partners who assist us with direct mail marketing. These business partners may share your information with subcontractors to perform services in connection with the operation of our business.

XUPERMASK collects and stores information from visitors to this Site, including those who register their information or who use the online store. For example, when you place

an order, we collect and store some or all of the following information that you provide: name, billing address, shipping address, email address, and telephone number. Credit card and payment information is only processed through our third-party service provider and not collected or stored at XUPERMASK. We refer to this information as "Order Information." This Order Information is used to provide the products and services that you have ordered or requested, to process and ship orders, to send order and shipping confirmations and to provide customer service.

This information also may be used for our own marketing and internal business purposes, and to communicate with you, including contacting you about sales, special offers and new site features, unless you have opted not to receive promotional communications in connection with this Site. To serve you better, we may combine information you give us with other information, which is publicly available.

We also may collect information regarding customer traffic patterns and site usage. We refer to this automatically collected data as "Device Information." Additionally, as our business continues to grow, we may acquire or sell a business. We reserve the right to transfer business and customer information in connection with such a transaction. In the event that XUPERMASK or substantially all of its assets are acquired, business and customer information may be one of the transferred assets. All business and customer information remains subject to the provisions of the Privacy Policy in place at the time of the asset transfer.

You should also be aware that we might disclose specific information about you if required to do so by law, governmental request, process or court order or based on our good faith belief that it is necessary to conform or comply with such law, request or court order or to protect the users of our Sites or the public.

YOUR RIGHTS

With regard to the collection and use of your personal information, there are certain rights available to you as the data subject. Depending on where you reside, there may be laws or regulations that list these rights specifically.

 - e. In connection with a sale or dissolution of any of our businesses; or

We may ask you for additional information to confirm your identity and for security purposes, before disclosing information requested to you.

While we will do our best to honor your request, we may not be able to do so in certain situations where you data is needed or required (e.g., complying with the legal process, record-keeping requirements, or facilitating a transaction upon your request).

When you place an order through the Site, we will retain your Order Information for our records unless and until you ask us to delete this information.
